COURT SPONSOR AMENITIES AGREEMENT

Company agrees to the terms below to be a Court Sponsor of the 2018 Spokane Hoopfest (“Hoopfest”) basketball tournament, located in Spokane, Washington.

Per Court Term of Agreement is as follows:

1. Sponsorship of one Hoopfest court utilized throughout the weekend. Sponsorship includes customization of the backboard with *Company* logo/desired artwork. All references to the court are in the name of the sponsor; therefore backboard artwork must include name.
2. Recognition as a court sponsor on all event maps.
3. Recognition as a court sponsor on Hoopfest's website (Spokanehoopfest.net).
4. One (1) complimentary team entry per court sponsored into Hoopfest (valued at up to \$180), subject to submission of a completed entry form prior to the designated deadline.
5. Eight (8) complimentary tickets per court sponsored to the Sponsor Garden, Hoopfest's weekend VIP area, in operation during the event.
6. Two (2) tickets per court sponsored to Tip-off, Hoopfest's annual party held in conjunction with the broadcast of the Men's NCAA Division 1 basketball championship game. Tip-off Party is held annually. A signed court agreement must be received by March 15 of each agreement year in order to receive Tip-Off tickets.
7. Opportunity to utilize the Hoopfest name and/or logo contingent upon approval from Spokane Hoopfest Association.
8. ***Company* will remit its sponsorship fee, as indicated on the Court Sponsor Form, to Hoopfest within 30 days of signing the agreement or by June 1 of each agreement year, whichever comes first.**
9. *Company* will provide or confirm existing artwork for backboard to Hoopfest by March 1 per each agreement year. Three year court sponsors are given one (1) graphic change throughout their three year agreement. The *Company* will be charged a \$100 production fee for any additional graphic changes exceeding the one (1) given. Please contact the office for further specifications if providing new backboard artwork. All *Company*-submitted artwork, for backboard publicity and any other promotional activities generated by Hoopfest will be reviewed and must be approved by Hoopfest prior to its usage.
10. Hoopfest agreement runs from September 1 through August 31. Therefore, this agreement will be in effect from the date fully executed through August 31 of specified sponsorship year(s).
11. Hoopfest encourages its participants and sponsors to make positive presentations of their affiliations through backboard design and other materials. Hoopfest reserves the right to exclude, limit or edit the content of all backboard messages and any other promotional material. Hoopfest may reject any message deemed to be offensive, controversial, or in any way exclusionary of its participants or other members of our community.
12. **Inclement weather and non-playable situations may result in the modification or cancellation of the event. Under these unlikely circumstances sponsor and vendor fees will not be refunded.**
13. This agreement constitutes the entire agreement and understanding of the parties, and supersedes all offers, negotiations and other agreements. There are no representatives or understandings of any kind not set forth herein. Any amendments to this agreement must be in writing and executed by both parties.
14. The obligations of this agreement shall be binding upon, and the benefits hereunder shall inure to, the parties hereto, their successors and permitted assigns.
